

INFORMATION ON THE TREATMENT OF PERSONAL DATA

Cantina Mesa S.r.l. Società Agricola, in its capacity as proprietor of the treatment of your personal data, (hereinafter "Data Controller"), has issued this information document in compliance with the European and Italian regulations on the protection of personal data, in order to inform you of the purposes and methods of processing personal data that you may share while browsing this website (hereinafter the "Website"). It should be noted that this information refers only to the Website, and not to third-party websites that the User may access through links present therein.

CATEGORIES OF DATA TREATED

Navigation data

During their normal operation, the computer systems and software procedures used to operate the Website acquire some personal data whose transmission is implicit in the use of Internet communication protocols. This information is not collected to be associated with identified interested parties, but by its very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes, for example, the IP addresses or domain names of the computers used by users who connect to the website, the addresses in URI (Uniform Resource Identifier) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response provided by the server (successful, error, etc.) and other parameters relating to the operating system and the user's IT environment. This data is used for the sole purpose of obtaining anonymous statistical information on the use of the website and to check its correct functioning, and is deleted immediately after processing.

Data provided voluntarily by the User

Sending e-mails to the addresses indicated on the Website - optional, explicit and voluntary - involves the subsequent acquisition of your e-mail address, which is necessary to respond to requests, as well as any additional personal data communicated. On the Website, there are forms to be completed, accompanied by specific information on the treatment of personal data carried out and, where necessary, by requests for consent - please read them before filling out the forms.

PURPOSE AND LEGAL BASIS OF THE TREATMENT, NATURE OF THE PROVISION OF DATA AND CONSEQUENCES IN CASE OF REFUSAL

The Data Controller will process your data to facilitate navigation and to provide any services you may have requested using the specific forms on the Website. Other than what is specified for navigation data and technical cookies, in the Website sections designed to accommodate particular on-demand services, you will be free to provide your personal data for the purposes indicated in the respective information notices, while aware that failure to provide such data may make it impossible to obtain the desired service.

DATA RETENTION PERIOD

The Data Controller will treat the personal data collected through your use of the Website for the time strictly necessary to achieve the purposes for which it was collected and, after this, for the time period established by current regulations, if so provided for.

SCOPE OF DATA COMMUNICATION AND CATEGORIES OF RECIPIENTS

The Data Controller will not disclose the data, but intends to communicate it to company staff authorized to process it according to their respective tasks, as well as to external subjects to whom it is necessary to communicate the data. These recipients, if they treat data on behalf of the Data Controller, will be designated as data processors with a specific contract or other legal act.

TRANSFER OF PERSONAL DATA TO A THIRD COUNTRY AND/OR AN INTERNATIONAL ORGANIZATION

Your personal data will not normally be transferred to non-European countries: the exceptions are described in the information made available along with the forms.

RIGHTS OF THE INTERESTED PARTIES

It is your right to ask the Data Controller to access your personal records and to rectify them if inaccurate, to delete them or limit their processing if the conditions for this are met, to oppose their processing for legitimate interests pursued by the Data Controller, as well as to obtain the portability of the data personally provided only if subject to automated processing based on consent or contract. You also have the right to revoke the consent granted for the purpose of treatments that require it, without prejudice to the lawfulness of the processing carried out until the time of revocation.
